Meet The Breed in The Big Apple NY 2024 is in the Books!! Our Boys, Maverick, Memphis & River were such great breed ambassadors.



Club officers and Legislative Liaisons: Please forward this alert to your club members.

A bill to allow the U.S. Department of Justice (DOJ) to circumvent USDA animal experts in enforcing federal breeder licensing and potentially undermine the current hobby breeder exemptions for USDA licensing is gaining traction in Congress.

Your U.S. Senators and Representative need to hear from you TODAY! Let them know you are a constituent and **ask them to not sponsor or support H.R. 5041/S. 2555**. Scroll down for details and contact information.

About the Bill: <u>H.R.5041</u>/ <u>Senate Bill 2555</u>, the so-called "Better CARE for Animals Act", circumvents enforcement of dog breeder licensing under the Animal Welfare Act (AWA) by the U.S. Department of Agriculture (USDA) and shifts authority to the U.S. Department of Justice (DOJ). This shift would move oversight authority from an agency staffed by animal experts that focuses on improving animal husbandry; and instead place it with one with little or no animal expertise that focuses on violations as potential federal crimes.

The bill would also empower the DOJ to file charges, seize animals and impose penalties regardless of whether USDA has determined or even alleged that there has been a violation of the Animal Welfare Act (AWA).

Additionally, the measure could potentially undermine or remove current exemptions from licensing for small hobby breeders, thereby requiring them to be licensed and comply with USDA standards.

Your Representatives in the U.S. House and Senate need to hear opposition to this bill TODAY!

Talking Points:

- Explain you are a constituent.
- Ask them to oppose H.R 5041/S. 2555, the so-called "Better Care for Animals Act".
- Tell them it will do precisely the opposite of its name by removing crucial animal experts from the chain of animal welfare oversight.
 Removing subject matter expertise will undermine both animal care and enforcement of violations.
- DOJ does not have staff, veterinarians or experts in animal husbandry and behavior that are experienced in evaluating AWA compliance or enforcement.
- Rather than creating more efficiency, HR 5041/S 2555 create redundant and potentially conflicting authorities and jurisdictions. This will cause greater bureaucracy and expand the backlog of cases at the DOJ.
- Removal of exemptions for de minimis activity such as hobby breeders will also create greater strain on the limited resources of federal agencies charged with AWA oversight of professional breeders.
- The measure is unnecessary as the USDA already can and does seek assistance from DOJ when appropriate.
- The bills allow owners to be required to pay for the costs of boarding and care of seized animals while legal proceedings are pending, regardless of the outcome – with no provision for restitution.
- Instead, suggest an alternate solution to address lawmakers'
 animal care concerns: Ask your members of Congress to instead
 support additional financial resources for USDA Animal Care
 enforcement, so they can appropriately enforce the requirements
 they already have.

Background: About Federal Dog Breeder Licensing and Oversight

Anyone who maintains more than 4 "breeding females" (a term that is undefined but is generally considered to mean an intact female) and transfers even one of the offspring "sight unseen" is subject to licensing under the AWA. "Breeding females" include any combination of cats, dogs, or other small pet mammals such as hamsters, guinea pigs, etc. (Learn

more). The U.S. Department of Agriculture's Animal and Plant Health Inspection Service, which is staffed by thousands of animal experts, currently administers AWA licensing requirements. As part of their mission, which includes improving animal care and welfare, the agency's experts recognize performance-based animal care standards and provide expertise, training, and certification programs that benefit animals and those who care for them.

Legislative Report

Current Legislation 11/16/2023

PA Dog Law Modernization, Act 18 of 2023

The PFDC has long supported increasing funding for the Bureau of Dog Law Enforcement. Since millions of dollars were taken out of the Dog Law Restricted Account to balance the General Fund budget in 2009, the BDLE has been running in the red and needing infusions of tax dollars to stay in operation. The increases in individual license fees and kennel license fees are moderate, especially considering it has been decades since they were last changed.

Since we were able to get amendments to both SB746 and HB1322 to protect the Health Certificate exemption for dogs coming into the Commonwealth for show, trials and other competitions, we supported the Bill and encouraged members of our member organizations to contact their state Senators and Representatives in Harrisburg to support them.

Some welcome changes include:

- Individual dog licenses will no longer cost more for unaltered dogs.
- The PA Department of Agriculture, Bureau of Dog Law Enforcement
 will be required to develop a web site to allow dog owners to purchase
 licenses online. We believe this will greatly increase individual dog licensing
 compliance.
- Future dog license and kennel license fees will be a matter of regulation. It
 will not be necessary to pass a Bill to change them going forward. However,
 we will still have a say with the PA Regulatory Review Board when new rates
 are requested, and Legislators have the ability to stop regulatory changes
 with a simple majority vote.
- The threshold for licensing a puppy will remain at 12 weeks *or when ownership of the puppy is transferred to anyone.* Sellers will be required to provide licensing paperwork to the buyers, but the responsibility will be on the buyers to obtain the license.

Some items of concern include:

- 2 week quarantine for dogs imported to the state permanently. This does not include dogs coming to PA for shows, trials, tests and other competitive events
- Change from a health certificate to a Certificate of Veterinary Inspection.
- Increase in penalties for those found to be operating a kennel without a license, to a class 3 misdemeanor, which could carry jail time. For those who may inadvertently exceed the 26 dogs "handled" in a year, because of the vagueness of that definition, we see this penalty as excessive.

Pennsylvania Senate Bills

 SB82 – License fee exemptions for service dogs used by fire dept, sheriff, rescue, medical emergency, municipal or state police. Declares dogs as personal property. SUPPORT

Pennsylvania Senate Bills (continued)

- SB357 Constitutional Carry of a Firearm. Would refer to hunting and sporting groups SUPPORT
- SB624 Lost Dog Hotline and Lost Dog Registry within the Bureau of Dog Law Enforcement. The question is funding sources given current shortfalls at the BDLE. SUPPORT
- SB658 (Mastriano) Combating Cruel Testing on Dogs and Cats. We question the need for this legislation because most institutions of higher education have ethics review boards that double check the need for the use of animals in scientific experimentation. We recognize the need for such use in both medical and veterinary science and do not support an out-right ban. Neutral
- Dogs used in medical and veterinary research. Generally speaking, we see the need for research using animal subjects, but obviously they need to be handled as humanely as possible. Most research facilities, both academic and private, have ethics review boards to evaluate the need for animal subjects. We believe most of those do a good job, so we question the need for these Bills. NEUTRAL
 - ♦ SB701 Regulating kennels that produce dogs for research
 - ♦ SB702 Amend Dog Law regarding research kennels
 - ♦ SB703 Amend Cruelty Laws regarding research kennels
- SB785 (Yaw) Animal Advisory Board. This board shall review existing laws and regulations in this
 Commonwealth related to keeping and handling of animals and make recommendations for legislative and
 regulatory changes. The board shall meet at least every two years, or as they see fit, to fulfill the duties under this
 act. The board shall develop an initial report making certain recommendations or regulatory changes that would
 need brought before the General Assembly.
 - ♦ This board will consist of the following:
 - » The Secretary of Agriculture or a designee.
 - » One member who is a resident of this Commonwealth from each of the following:
 - The University of Pennsylvania School of Veterinary Medicine.
 - The College of Agricultural Sciences of The Pennsylvania State University.
 - The American Kennel Club.
 - The Federated Humane Societies of Pennsylvania.
 - The Northeast Beagle Gundog Federation.
 - The Pennsylvania Society for the Prevention of Cruelty to Animals.
 - The Pennsylvania Farm Bureau.
 - PennAg Industries Association.
 - The Pennsylvania State Grange.
 - The Insurance Federation of Pennsylvania.
 - The Office of Attorney General.
 - The Pennsylvania State Police.
 - The Pet Advocacy Network.
 - » Two members who are residents of this Commonwealth from each of the following:
 - The Pennsylvania Federation of Dog Clubs, at least one of whom represents a licensed kennel.
 - The Pennsylvania Veterinary Medical Association.

The Legislative Committee of the PFDC supports Senator Yaw in his efforts and appreciates the opportunity of two (2) seats at the table. Should this bill pass and the Advisory Board becomes a reality, we are well aware that this will be a battleground of animal rights vs animal welfare. However, we are prepared for the challenge of reviewing those existing bills that need amended and new bills that require scrutiny. This will be our opportunity to educate legislators by voicing our needs and positions regarding current and future legislation. We will make every effort to align our positions with like-minded animal welfare members of the board and continue to protect our member clubs, their members, breeders and their dogs.

• SB979 (Culver) – Public Information Regarding Bio-Security. This proposal would require retailers of livestock and pet food to post notices of "dangerous transmissible diseases". Support

Pennsylvania House Bills

- HB86 Legislation to allow any 501c3 or 501c6 organization to sell liquor for fundraising purposes. Neutral
- HB139 Taking the Judiciary out of Dog Law under current law, all fines, fees and costs collected are
 deposited into the Judicial System account. The transfers include amounts imposed under Act 225 AKA Dog
 Law that would be used to fund the operations of the Dept of Ag, which oversees Dog Law Enforcement. This
 legislation addresses this issue by exempting fines, fees and costs under the Dog Law from being transferred to the
 Judicial Computer System. Accounts for approximately 200K per year. SUPPORT
- HB222 Cruelty to Animals violation causing bodily harm due to cropping, trimming or cutting off the
 whole or part of the ear or ears of the animal by a person who is not a licensed Doctor of Veterinary Medicine.
 SUPPORT
 - ♦ 1st offense misdemeanor of the 2nd degree
 - ♦ 2nd offense misdemeanor of the 1st degree
- HB449 Kidnapping of Animals Establishes tough penalties for intentionally selling or taking of any dog, cat, equine, swine, cattle any animal to resell to puppy mills, research facilities or animal Fighters. Neutral pending clarification.
- HB508 Banning of cat declawing specifically refers to only cats; however, it refers to "animal mutilation," which we all should know that the AR groups refer to dewclaw removal, cropping and docking as "mutilation." This is a private decision between the owner and their vet. (Should this bill pass, their next step would be dogs.) OPPOSE
- HB526 Requires pet shops to provide all health, medical and breeder licensing numbers "keeping breeders honest" SUPPORT
- HB529 Animal Cruelty Transporting dogs supported by the American Humane Society prohibits
 transporting of dogs unrestrained in truck beds or car roofs. This proposal will "not apply to a dog transported
 in a secured insulated cage or container which is designed to facilitate the safe transportation of a dog and will
 prevent the dog from being exposed to outside weather conditions and from falling, jumping or being thrown
 from the vehicle." SUPPORT
- HB530 Animal cruelty Restriction of Animal Ownership all "convicted" abusers prohibited from owning, possessing, controlling or working with animals for at least 2 years also requires abusers to participate in violence prevention counseling. *NOTE: Refers to Libre's Law (Act10) Over 25,000 Animal abuse cases have been filed statewide 54% for neglect. OPPOSE
- HB549 All Dogs Equal All Dogs in all kennels should be held to the same State licensed standard that requires specific construction, heating, cooling, exercise, etc. *NOTE Rescue/rehomers are generally not State licensed. This bill would include those groups. SUPPORT
- HB607 Introduces legislation to permit the Attorney General to investigate and institute criminal proceedings for a felony offense regarding animal cruelty to animals. This would permit the assistance of the Attorney General in prosecuting animal cruelty cases in counties which have little experience in doing so. *NOTE The Attorney General's office is in partnership with the H\$U\$. OPPOSE
- HB689 Applies to crimes and offenses relating to sexual intercourse with an animal. *NOTE We read this bill specifically searching for AI use. In another state where a similar proposal was introduced, it included artificial insemination as a sexual offense. That was not listed in this bill, so we are concerned about its intent. We want Representative Jordan Harris to clarify the proposal's intent on that topic. NEUTRAL
- HB1052 Exempting Detection Dogs from licensing. SUPPORT
- HB1099 Defend the Flock. On the surface, this Bill is about poultry flocks. However, the definitions in it
 concern us because they could be interpreted to apply to all domestic animals. We are currently NEUTRAL but
 will continue to monitor it.
- HB1108 (Kulik) Animals in Divorce Cases. This Bill has a very problematic definition of domestic animals and some assertions about pets as property that worry us. Oppose as written pending clarification.
- HB1210 (Sappey/Mihalek) Animal Abuse in Domestic Violence Situations. This is a "we are doing something
 about this horrible problem" proposal that is actually unnecessary because such abuse is already illegal under
 Humane Laws. Do Not Support because of redundancy.
- HB1661 (Metzgar) Criminalizing illicit possession of xylazine, with veterinary use exemptions. This proposal
 seeks to criminalize the illicit use of xylazine by people for recreation, while keeping the necessary sedative
 available to veterinarians. Support

Pennsylvania Senate Resolutions

• SR57 – Sen. Mastriano, Designate March 13, 2023 as "K9 Veterans and Service Day" in PA. "Canine services include dogs and their handlers, trainers and other helpers involved in police services, drug enforcement, customs, border patrol, secret service, military, and many other capacities. In my view they have earned our thanks for their efforts to protect us all." SUPPORT

FEDERAL LEGISLATION

• HR1624 – Puppy Protection Act. This H\$U\$-backed proposal is an incremental approach to bringing everything we do under Federal oversight. It is their common one-size-fits-all approach that mandates practices down to a minute level. The mandates include...

Prohibiting the breeding of a female dog:

- Unless pre-screened by a veterinarian
- Based arbitrarily on the age and size of the dog.
- If it would produce more than two litters in an 18-month period.

Additional arbitrary requirements include but are not limited to:

- Mandated unfettered access from dogs' primary enclosures to an outdoor exercise area large enough that it
 "allows dogs to extend to full stride." This would create a potentially dangerous environment for multiple dogs.
- Mandated annual dental exams.
- Mandated indoor space sufficient to allow the tallest dog in an enclosure to stand on his or her hind legs without touching the roof of the enclosure. For family dogs that live in their owner's homes, the primary enclosure may be considered the dog's sleeping crate.
- Mandated pre-breeding screenings. No specific details are provided for what the screening would involve or who
 would make these decisions.
- Prohibition on the keeping of dogs in enclosures above 85°F or below 45°F, regardless of breed or acclimation needs for dogs that hunt, sled, detect explosives, or do other work and thrive in cooler temperatures, or that must be acclimated to cooler or warmer temperatures for their safety.
- Completely solid flooring, despite scientific recognition that multiple types of high-quality flooring, including
 engineered slatted flooring, is beneficial in certain types of kennels and with certain breeds.

- HR1788 Include Livestock and Poultry in the AWA (Goldies Bill) more incrementalism on the part of those who are opposed to any animal ownership, including our dogs. They use the phrase "puppy mills" in reference to USDA licensed kennels, which they are not. It tries to define "suffering" as almost anything short of pushing them around in a baby carriage. The proponents are attempting to include the proposal in the current Farm Bill. OPPOSE

Supreme Court ruling on California Pork Import regulations, and the EATS proposal

On the surface, it seems this has nothing to do with dogs or us. Unfortunately, that is not true. The ruling carries a precedence that is still being evaluated. It could lead to California's exceedingly strict animal laws being applied to breeders in the rest of the country. Everyone should pay attention to this developing story.

In response to this ruling, Congress has introduced the Ending Agricultural Trade Suppression (EATS) Bill (H.R. 4417/S. 2019). This would prevent animal-related Bills passed in one State from affecting the Laws and Regulations of others. It was proposed as a way to address livestock regulations in California that are creating a burden for producers in other states. We see how this could be applied to breeders and puppies being shipped between states. **SUPPORT**

New Hampshire HB1102 is a Step in the Wrong Direction for All Dogs in All States

One thing is perfectly clear with regards to this proposal: this is only the first step. Today it is only New Hampshire, and the condition is only Brachycephalic. Make no mistake, proponents of this proposal, which started in Europe, will not stop until they have a laundry list of conditions, in a lot of States. We are quite sure; their ultimate goal is to make it Federal Law.

A major problem with this proposal is who decides what breeds are brachycephalic. Will it be politicians who have little knowledge of animal husbandry, agenda-driven, unelected bureaucrats or veterinary academics who may also be driven by a radical agenda?

Next question would be are all members of that breed then considered to be suffering from the condition, or are individuals evaluated? Clearly there members of breeds currently labeled brachycephalic that compete at a high level in agility, Fast CAT and other strenuous sports successfully. How can this one-size-fits-all proposal legitimately say those animals are suffering?

We believe consumer education is the best way to address any excesses that lead to animals suffering. Consumer protection proposals like the PA Dog Purchaser Protection Act (Puppy Lemon Law) are far more effective than one-size-fits-all proposals like New Hampshire's HB1102.

We urge all members of all our member clubs to watch for similar proposals, even at a local level. Even if your favorite breed is not brachycephalic, think about what conditions are inherent in them that could be used to regulate or eliminate their breeding should this type of legislation get a foot-hold. Please let us at the Pennsylvania Federation of Dog Clubs know as soon as possible if you hear of any similar proposals anywhere, even in other States.

Senator Fettermen,

The Pennsylvania Federation of Dog Clubs and its many member organizations across the Commonwealth are very concerned about the "Better Care of Animals" proposal currently under consideration in Congress. We do not believe the proposal will have the effect its name implies, but will, in fact, achieve the opposite result.

Removing subject matter experts from the enforcement of the Animal Welfare Act is inefficient and counter productive. Inspectors at the Department of Agriculture have spent decades learning animal husbandry practices at a practical level, instead of a political one. The Department of Justice on the other hand has shown itself to be strongly affected by the political winds on the day. We know that some vocal activists make a living out of vilifying traditional agricultural practices and we are sure those will be the voices heard by lawyers at the Department of Justice. Hopefully, legal representatives of farmers will be able to show this in court, but that will take significant financial resources and time out of the fields for our farmers. This undoubtedly have the effect of driving up food and other costs even faster than they are today.

The way S.2555 is written, it will cause redundancy between the Departments of Agriculture and Justice, wasting taxpayer dollars. The Department of Agriculture already requests DOJ assistance as necessary.

Another concern for us is the implication in the proposal that hobby breeders be treated the same as professional breeders. This will cause a greater caseload strain and reduce the effectiveness of current inspections, regardless of which Department is conducting them. This strikes us as part of a radical animal activist agenda to end hobby breeding, showing, trialing and other family friendly activities Americans enjoy with their animals. Siezing animals and forcing owners to pay for boarding prior to their day in court, and not allowing for refund of those fees should they be acquitted is an Unconstitutional seizure of property without due process.

We would much rather see Congress increase support for USDA/APHIS inspection activities in support of the Animal Welfare Act as it stands today.
