






#### **LBDTC New Training Site Membership Survey, Preliminary Report**

At the direction of the Board of Directors, an eight (8) question survey was prepared for members to complete via the Planet Survey web site. The purpose of the survey was to gather the opinions of the club membership regarding the possibility of the club obtaining a new training site.

The survey was activated online from May 30<sup>th</sup> through June 30<sup>th</sup>, 2024. A total of 35 members completed the survey. This is approx. 75% of the membership responding to the survey.

Question #1: Do you agree LBDTC needs an improved training location? Of the 35 respondents, 77.1% agree an improved training site is needed and 22.9% disagree.

Question #2: What about the current location concerns you? 42.2% felt that size was a primary issue, 17.2% felt storage capacity was a secondary issue and 14.1% had no concerns. Less than 10% of respondent were concerned with Location, Security and Creature Comforts.

Question #3: Would you like any new location to be large enough to setup an AKC sized ring? Almost half of the respondents (48.6%) would like it, if possible. The remaining respondents were evenly split between wanting a facility which could accommodate an AKC size ring and not (25.7%) each way.

Question #4: How much do you feel we should increase our budget for a new training site? 48.6% of the total respondents felt and increase in the range of \$5K – \$10K would be appropriate, while just under one third (31.4%) felt there should be no increase.

This is only a preliminary report of half of the responses. A formal presentation will be made at the September 9<sup>th</sup> club meeting and digital copies of the final report will be available
